### What should I do if I already registered the internship course in this term (2/2019)?

### What should I do, if the grade of pre-requisite courses (in 2/2019) announced after the registration in (1/2020)?

Student can register in 1/2020 as usual, while the grade (2/2019) not announced yet. After your grade result not meet the requirement in any course especially the pre-requisite course, the university will cancel that specific course's registration automatically. Student will get its credit fee refund.
